### Academic Calendar

Fall 2025: August 18–December 5

Spring 2026: February 2–June 19

Fall 2026: August 18— December 5 (tentative dates)

**Important Note:** CIDE cannot emit official grade reports or transcripts until after the end-of semester professors' meetings. For the Fall semester, these meetings are normally held in late January and for the Spring semester in early August.

### Language Requirements: Spanish B2

Although some courses are offered in English, the official language of instruction at CIDE is Spanish, and it is important to be prepared to complete course work in this language. Many professors, however, will accept written assignments in English. CIDE may require incoming students to take an additional Spanish course.

### Grading criteria:

Grades at CIDE are numerical. The highest possible grade is 10. Any grade below 6 is failing.

### Credits:

On average, a 60-hour course corresponds to 8 credits, but this may vary based on class hours type of instruction.

### Application procedure and required documents

Students nominated by an institution that has an exchange agreement with CIDE:

- completed application form
- statement of purpose, written in Spanish, explaining your interest in studying at CIDE
- official transcript, including current courses
- proof of Spanish-language proficiency
- copy of the identification page of your passport (Mexican citizens may submit a copy of their national identity card [INE])

Students interested in completing a semester as a visiting student should contact us for information on the steps and fees involved.

### Visas.

Mexican visa requirements depend on nationality and length of stay. For a stay of one semester, students who do not require a visa to visit Mexico as a tourist will not require a student visa. For a stay of more than 180 days (two semesters) a student visa is required regardless of nationality. Please consult with the Mexican embassy or consulate in your home country.

### Medical insurance.

Once accepted and prior to arrival in Mexico, incoming exchange students must send a copy of medical insurance and repatriation coverage valid for their entire stay in the country.

### Housing network.
